The Coastal Watershed Council is a science-based nonprofit based in Santa Cruz, CA. Since 1995, the Coastal Watershed Council (CWC) has been working to preserve and protect coastal watersheds through community stewardship, education and monitoring. Coastal Watershed Council has a renewed focus on transforming the San Lorenzo River to become a draw for residents and tourists, a clean and thriving place of safety and community pride, and a driver of economic activity. In the past fiscal year CWC trained over 150 volunteers, contributing 1,151 hours of their own time studying local creeks and rivers, generating 964 scientifically valid data points in 50 water bodies along California's Central Coast. CWC also inspired and educated 3,334 youth to become future scientists, watershed
